On the 7<sup>th</sup> December 2010, the president of Slovenia, Dr. Danilo Turk and the first lady Barbara Miklič Turk hosted a reception for the representatives of humanitarian organisations in the big hall of the Presidential Palace in Ljubljana. It was a great honour for Humana, one of EUFAMI's members in Slovenia, to receive an invitation to attend the event. The president in his speech emphasised how strongly he appreciates the contribution organisations have had in solving the problems of poverty, social isolation and sometimes violence, discrimination and low tolerance. He also added that this help has especially been valuable in the past two years, when economical troubles which

Slovenia has been dealing with, have further tightened the bad conditions.
