Health at a Glance - Europe 2012

On 16th November, the European Commission (DG Health and Consumers) jointly with OECD, published the report "Health at a Glance: Europe - 2012". The report presents a set of key indicators of health status, determinants of health, health care resources and activities, quality of care, health expenditure and financing in 35 European countries, including the 27 European Union member states, 5 candidate countries and 3 EFTA countries. The selection of indicators is based largely on the European Community Health Indicators (ECHI) shortlist, a set of indicators that has been developed to guide the reporting of health statistics in the European Union. It is complemented by additional indicators on health expenditure and quality of care, building on the OECD expertise in these areas. Some key findings include:

- Growth in health spending per capita slowed or fell in real terms in 2010 in almost all European countries Life expectancy at birth in EU member states has increased by over 6 years between 1980 and 2010
- More than half (52%) of adults in the European Union are now overweight, and 17% are obese
- Spending on disease prevention falls by 3.2% in 2010

Schizophrenia Commission releases it report

For the past year, an independent commission on schizophrenia and psychosis, facilitated by Rethink Mental Illness, scoped the state of care and outcomes for people living with the condition in England. On the 14th November, the Commission released its final report titled 'The abandoned illness', and amongst the findings it reveals a dysfunctional system that does not deliver the quality of treatment needed for recovery. New Mental Health Strategy for Wales

Our Welsh member, Hafal, has informed us that their government recently launched its new Mental Health Strategy "Together for Mental Health" and an initial three-year Delivery Plan. The Strategy sets out the Welsh Government's vision for 21st century mental health services and is the first mental health and wellbeing strategy for Wales covering people of all ages. The Strategy reinforces the legal framework put in place by the Mental Health Measure and its accompanying Regulations

and Codes of Practice. The Delivery Plan sets out a three-year programme of improvement, cranking up the progress required for service delivery. In the next few weeks Hafal plan to issue a detailed analysis of the strategy.
